

**Background**

This matter came before the commission by complaint under child right protection act 2005. The matter was referred by the Hon'ble Minister, Women and Child Development, Government of Maharashtra for enquiry.

2. In the complaint, complainant Shri Rahul Daga resident of Dosti Acres, Wadala (East), Mumbai has alleged that his son Master Dhruv Rahul Daga who is student of Tree House Pre-school located within Dosti Acres was met with an accident on September 13, 2012 due to negligence of management and staff of school. Master Dhruv suffered grievous injury in his middle finger of left hand and got operated at P.D.Hinduja Hospital, Mahim on the same day.

3. The complainant had made complaint about the incidence on 19<sup>th</sup> September, 2012 to the Managing Director of Tree House Education & Accessories Ltd. This issue appears in newspaper also. The commission took cognizance and issued notices to the complainant, Managing Director of Tree House Education and Accessories Limited, Police Department, Education officer of Municipal Corporation.

4. The police inspector has submitted an written reply and mentioned about the incidence in detail, along with copies of Panchanama, F.I.R. and medical certificate. In the report as submitted by the police inspector on 20<sup>th</sup> October, 2012, it is mentioned that when Dhruv was standing behind the door then another child Sharvit Soni, age 2.5 years pushed the door, due to this middle finger of left hand of Master Dhruv was injured and started bleeding. The staff of school did primary treatment and also informed his parent about the incident. Thereafter child was admitted in the hospital and operated upon his middle finger. In the said matter complainant Mr.Rahul Daga was appeared before commission. Suvarna Tendulkar, legal officer, Tree House Education and Accessories Limited appeared on behalf of school and submitted written apology. She expressed in writing that school is ready to reimburse medical expenses. Complainant Mr. Rahul Daga has shown his willingness to settle the case. School has given cheque for Rs.40,000/- pertaining to medical expenses and Rs.24,500/- for fees.

5. On the basis of settlement made between the parties, the matter may be disposed off.


6. **Commission's recommendation is as follows:**
