**In the matter or enquiry of Children Homes in district Buldhana**

**C.R.No.79**

**Background**

The State Government, by its letter dated 4/6/2011 requested the Commission to conduct enquiry on the conditions of children homes in the state, on the basis of the report of the team constituted at the district level.

2. Matters related with 22 districts were forwarded to the Commission. Districts include Parbhani, Beed, Osmanabad, Latur, Nanded, Ahmednagar, Kolhapur, Sindhudurg, Ratnagiri, Sangli, Satara, Solapur, Buldhana, Nandurbar, Aurangabad, Jalna, Wardha, Yavatmal, Mumbai City, Akola, Raigad and Dhule. The Commission took cognizance and conducted enquiry under Commission for Protection of Child Rights Act 2005 on priority basis first pertaining to the Districts Parbhani, Beed, Osmanabad, Latur and Nanded (where majority of children homes are permitted) and submitted reports to the Government for Parbhani on 10/7/2012 vide letter No.BHA/C.R.149/421, for Beed on 2/7/2012 vide letter No. BHA/C.R.150/ 2012/13, for Osmanabad on 2/8/2012 vide C.R.No.95/447, for Latur on 10/8/2012, vide letter No.C.R.385/487, for Nanded on 21/7/2012, vide letter No.BHA/2012/C.R.162/2012-13/444. Ahmednagar on dated 13/4/2015, vide letter No.BHA/2014/c.r.186/2015-16 /312. Enquiry report regarding Kolhapur, Sindhudurg, Ratnagiri, Sangli, Satara and Solapur on 6/7/2015.
3. In the Buldhana district list of children homes are given in the annexure A. On the basis of available records and enquiry report submitted by the team constituted at District level, the Commission has observed that out of total four children homes, three children homes have followed procedure, in one children home category of children are not in consonance with the provision of law. However in general, conditions of Children Homes are good. As matter is old therefore without going through the process of enquiry under Section 13(1) and 14(1) of Commission for Protection of Child Rights Act, 2005, on the basis of observation made by the team, and considering the facts of case and vetting the facts under the purview of

provisions of Juvenile Justice Act. The Commission is making following recommendations.

- i. To undertake survey and ascertain the no. of fit children who fall under the categories of "need for care and protection", homes in the district and on the basis of survey if required then new children homes may be opened.
- ii. Children who do not fall under the categories as prescribed in the sub clause 2(d)(I) to (IX) should not be allowed to retain in the homes and appropriate action should be initiated in this regard.
