Background:-

This matter came before the Commission by filing a complaint of one Shri Paul David, making allegation against Morning Star English School. School is running in the Church without permission, therefore, action should be taken against the School.

2. Commission took the cognizance, issued notice to Morning Star English School and on behalf of the same School filed reply, stating the various issues including the locus standi of the complainant.

3. In this matter, right of children has not been violated either under C.R.C. Act, 2005 or R.T.E. Act, 2009, therefore, complainant may kindly be rejected at admission stage. Heard the matter, went through the papers, it is found that complaint is baseless, therefore, matter is disposed of without any recommendation.
