


Background

This complaint is filed on letterhead of Bahujan Vidyarthi Sanghatana making allegation against Mrs. Suttar, principal of Scholar's English school. In the complaint it is alleged that school is taking donation, and also not filling quota prescribed under 25% under R.T.E. Act. Further, alleged that principal of school Mrs. Vishakha Suttar is used to make comment & taunt upon the children belonging from weaker section of society saying that if they are not able to give the fees then they are free to leave school and free to get admission under Municipal corporation school. The Commission has issued notice to concern school. The school has filed reply denying charges as mentioned in complaint & submitted that this is nothing but malaying the character of Head teacher & misusing the letterhead of Bahujan Vidyarthi Sanghatna.

2. It is also submitted that complainant also approached to police. Despite of notices issued by Commission, complainant did not give any reply on submission of school. As this matter is related with admission in K.G., therefore does not come under purview of R.T.E. Hence matter is disposed off without recommendation
