Background


This matter has been referred by the National Commission for Protection of Child Rights requesting this Commission to initiate enquiry. The case reveals that 4 years old child was raped in the bus by bus conductor. Matter was listed by the Commission. Concern police officer who appeared, before the Commission, filed report, which reveals appropriate action, has been initiated by the police. Accused has been arrested; charge sheet has been filed before court. Regional Transport Office has suspended license of vehicle. Police has initiated action against accused. Principal of school also filed reply and submitted that, bus was taken on lease by the school and owner of bus along with his wife was working as conductors, therefore contention that bus was not having women conductor is not correct from his submission. He has shown his regret on the incidence.

2. Since this matter is subjudice and police has taken appropriate action. Therefore this matter is disposed of directing police to submit status report.
