Background

This matter brought before the Commission by the office of Hon'ble Minister, Women and Child Development. Complainant Shri.Lalchand Patawa who made complaint against Mr. Premkumar Kevat in the police station, alleging that his minor daughter Ms.Shivani was kidnapped by Shri.Kevat. The police registered the case under section 363 of Indian Penal Code and provision of Protection of Children Against Sexual offences Act 2012. The police has initiated investigation and rescued his daughter i.e. Ms.Shivani from Allahabad. After permission of Child Welfare Committee Ms.Shivani was placed in the children home. The complainant raised allegation against concern police officer and alleged that entire expenditure on rescue operation have been borne by him.

2. Superintendent, Children home Shri.Jadhav, has filed his submission stating that daughter of Complainant is with the parents and she did not indicate allegation against the children home. No submission is made by the police.

3. Commission heard the matter and pass following recommendation :

The matter is disposed off with the direction to the Commissioner of Police, Mumbai to enquire the matter and submit report.
