**Background :-**

This matter has been filed by Childline, Buldhana, raising, an allegation that on account of incident happened in Buldhana, where child was assaulted sexually a case was registered on 22nd November, 2015. However, due to inaction of police department, the child's family is facing the problem in getting justice, therefore, prayed the Commission, for necessary action in this matter, in order to provide justice to the child.

2. The Commission took the matter, issued notices to the concern Police Officer and listed matter on 21st December, 2015 and 4th January, 2016.

On 21st December, 2015, Commission passed the following directions:-

Mrs. Chandekar, Director of Childline, Buldhana, appeared before the Commission and presented the matter, explaining the incident, raised the issues regarding bail granted by concern Hon'ble Magistrate, non co-operative behaviour of concern Police Officer, meeting with the concern Magistrate. She submitted that the Hon'ble Magistrate informed that since Police did not ask for the P.C.R., therefore, the accused was released on bail. It is also informed by the complainant that, in this matter she met Chairman and Member of the Child Welfare Committee on 28<sup>th</sup> November, 2015. However, C.W.C. did not take any cognizance. A report of Police Inspector received in the Office of the Commission on 19<sup>th</sup> December, 2015. Directed to handover a copy of the report submitted by police to the complainant. Complainant is being directed to file affirmed reply on the contents as placed orally before the Commission and also directed to file her say on the report submitted by Police. Listed the matter for next hearing, i. e. on 4<sup>th</sup> January, 2016, directing Chairman of the C.W.C., concern Police Inspector, to appear before the Commission. As asked, by the father of girl that due to threat, received from the accused. He needs police protection. The Superintendent of Police Buldhana, is being directed to look this matter and extend proper protection to the father of the girl child, if required.

On the next hearing, i. e. on 4th January, 2016, the Commission passed the following order:-

The volunteers of Childline were present during hearing. Admitted that action taken by Police is appropriate, therefore, they are satisfied with the action of the police.

3. On the basis of record and submission made by volunteer of Childline, matter is disposed of without any recommendation.
