Suo Moto

Introduction:-

This matter has been taken up by the Commission suo moto on the basis of newspaper report in which it is indicated that within the jurisdiction of Mira Road Police Station, the 11-year old domestic helper was beaten and regularly assaulted by her employer, approached the police with the help of N. G. O. and neighbour made a complaint. The report says that the girl was purchased by the couple from her parents from their native place Badaun in Uttar Pradesh for Rs.15,000/- on pretext of adopting and educating her.


2. Commission took the cognizance, issued the notice, called the Police Officer of concerned Police Station. Police Officer, Shri Divakar appeared before the Commission and submitted detailed report. In the Police report, it is mentioned that police has registered F.I.R. under section 373 of I.P.C. alongwith sections 7 and 8 of POCSO Act. Alleged accused, Shri Sargil Safik Ahmed, has been arrested and searching of other accused, i. e. his wife is going. The police party went to Badaun in Uttar Pradesh for searching the parents of victim. However, they cannot be traced. The police is also trying to get the anticipatory bail cancelled as filed by accused No.2.

3. After going through the police report and assurance given by police that police will try to arrest the accused, and within prescribed time, charge sheets

shall be filed. Hence, the matter is disposed of directing police to submit the progress report in this regard.
