Introduction:-

The Commission has taken up this matter suo-motu on the basis of news report mentioning that in the Akola District at Babulgaon Jahagir in the Navodaya School (the Ministry of Human Resources, Government of India). Two teachers name Shailesh Ramteke and Rajan Gajbhiye who were regularly sexually assaulting the girl students regularly, were booked under the various sections of IPC and POCSO for their act of criminal wrong. The police has arrested both the teachers and two other accused who assisted to commit the crime.

2. The Commission listed this matter, issued notices to the Superintendent of Police, Akola, District Woman and Child Development Officer and Principal of Jawahar Navodaya Vidyalaya Babulgaon Jahagir, Akola. Police has submitted the report mentioning a detailed report mentioning that how teachers were sexually exploited the girl students. In the report, it is mentioned that police has registered ~~the~~ case, arrested the accused and ~~accused are in police custody~~. District Woman and Child Development Officer submitted a report on the basis of statement given ^{by} girl students ^{and} teachers and outcome of the report indicates that both the teachers and their associates were sexually exploiting the girl students. Even they were blackmailing the girl students. During the practical classes, condoms were shown by the teachers, Investigating Officer appeared before the Commission and submitted that in

this matter charge sheet has been filed against the accused, and matter is in the court. Accused are suspended as reported by the Principal. Investigating Officer has further submitted, for providing services of counselor for the girl students who are mentally disturbed.

3. In this matter as reported by the Police and the District Woman and Child Development Officer, action has been taken by Authorities, matter is in the Court and only ~~is~~ counseling is required. Therefore, Commission is making the following recommendation:-

(i) Officer of District Child Protection Unit is directed to visit the School and initiate the counseling with the help of Principal of Jawahar Navodaya Vidyalaya.

(ii) In order to create awareness among the student regarding rights of children and provision of various acts in this regard, intensive awareness program should be started in the school.
